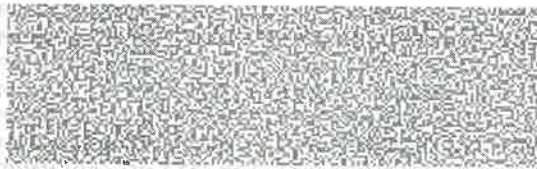

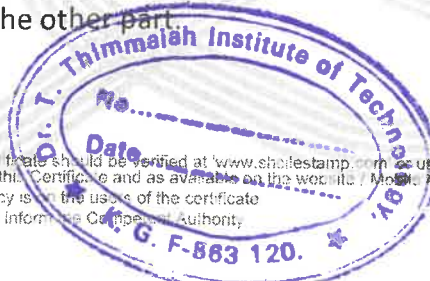

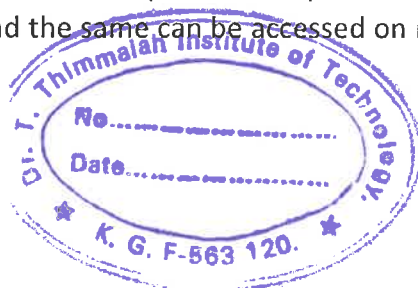

### 4. Termination:

This Agreement shall automatically terminate on the expiry of the period of

- a. 24 months from the date of signing of this Agreement or completion of the project including final payment and documentation whichever is earlier as provided above unless extended by the Parties by mutual consent.
- b. Parties may terminate the agreement after giving a notice in writing of third days' time the other party of its intention to terminate the agreement.
- c. In the event of any lapses in execution by any party, the other party shall have the right to terminate this agreement by giving a 30 days' notice to the defaulting party.

### 5. Amendment:

Any Amendment to this agreement shall be valid and binding on the Parties only if it is made in writing and signed by duly authorized representatives of each party.

### 6. Notices:

All notices and other communications shall be sent to the address of each Party set forth at the beginning of this agreement.
